Privacy Declaration Faculty Association Ibn Battuta

This is the privacy declaration of Faculty Association Ibn Battuta.

With this document, we want to inform you which (personal) data we collect, with which purpose, and what we do with the data.

We will only process this data for purposes that are stated in this declaration and we will take the needed measures to protect the collected data in accordance with the current legal requirements.

What is personal data?

Personal data is all data by which a person can be identified.

How is your personal data being collected?

Ibn Battuta collects the personal data that you filled in while signing up for Ibn Battuta, or when becoming a Friend of Ibn Battuta. Ibn Battuta has a database in which your personal data is documented.

How are we going to use your personal data?

- Your first and last name are being used for the following purposes:
 - o When you signed up for an activity (only visible for members & Friends)
 - o The member section in the (online) almanac
 - o Administrational purposes
 - o Inviting you to make a connection on social media for promotional purposes
- Your address data is being used for the following purposes:
 - O When we unexpectedly cannot reach you by phone
 - o Sending cards and letters
 - o During unforeseen circumstances
- Your phone number is being used for the following purposes:
 - o To get in touch with you when you ask for this, or when necessary
 - o The member section in the online almanac
 - o Adding you in Whatsapp Groups
- Your email address is being used for the following purposes:
 - o To provide you with information
 - o The member section in the online almanac
- Your IBAN is being used for the following purposes:
 - O Automatic collections to make sure all payments for activities can be handled as fluently as possible. This will **never** happen without your consent.
- Your date of birth is being used for the following purposes:
 - o The member section in the (online) almanac
 - o Administrational purposes
- Your study and starting year of study are being used for the following purposes:
 - o To reach you for targeted promotion
 - o The member section in the (online) almanac
- The following personal data are **only** used for administrational purposes:
 - Student number
 - o Gender

How are we going to use pictures and video material taken by Ibn Battuta?

The pictures or videos that are taken by Ibn Battuta during activities and other events can be uploaded on the website and can be used for promotional purposes. These pictures are selected carefully and all other pictures that are not on the website will be deleted. The pictures on the website are only visible for members & Friends. In addition, Ibn Battuta can use these pictures or videos for physical and online promotion material via:

- Newsletters for our members, Friends and partners
- > Posters
- > Almanac
- Social media posts
- > Aftermovies
- > Television Screen in the Coffee Room
- ➤ Website content
- Lecture talks with Powerpoint Presentation

Ibn Battuta keeps the right to preserve the pictures or videos that are taken on activities, after they have been visible on the website. If you do not agree with a picture or video of you being visible on the website, being used for promotion, or being preserved by Ibn Battuta, you can reach out to the board through phone, email or personal contact and they will make sure it will be deleted.

With whom are we going to share your personal data?

Ibn Battuta will only share your personal data with third parties when this is necessary for carrying out an agreement with you, or to comply with a legal obligation.

What are your privacy rights?

- You have the right to access the personal data that we collect from you
- You have the right to ask for a correction, or ask to delete your personal data
- You have the right to appeal against the use of your personal data
- You have the right to request a transfer of your personal data
- You have the right to be 'forgotten'
- You have the right to limit the processing of your personal data

If you want to make use of these rights, you can reach out to the board through phone, email or personal contact.

How long is your personal data being saved?

Ibn Battuta will never save your personal data for longer than strictly necessary to realize the goals, for which your data are collected. Your data will not be saved for longer than a year after your membership has ended, if there is no agreement with you concerning this.

Can this document be changed?

Ibn Battuta keeps the right to adjust this privacy declaration. We recommend you to regulary consult this privacy declaration, so that you stay informed about possible changes. When necessary, we will inform you beforehand about changes.

Can I submit a complaint at 'Autoriteit Persoonsgegevens' (The Dutch authority for the protection of personal data)?

You can always file a complaint at 'Autoriteit Persoonsgegevens' about the processing of your personal data when you cannot reach an agreement with Ibn Battuta.
